**Match Length:** 3 -1 minute periods (Choice for 2nd & 3rd periods). 10 pt TECH FALL. OT 1 minute sudden victory if no points scored / 30 sec. tie breaker (choice to wrestler that scored first, if 0-0=flip. NOVICE MATCHES = ALL RESTARTS NEUTRAL

**Rules:** Modified Scholastic Rules will be used for all divisions. Tournament will be double elimination or round robin. Tournament Director reserves the right to combine weight classes upon need. If you do not get 3 matches in your bracket, you can jump in a 2nd bracket (division or weight class) for FREE.
